

MARKET COMMENTARY

The **DCI** decreased **0.07%** to close the week at **8049.91** points. The **FCI** remained flat to close the week at **1563.48** points. **NAP** (+10 thebe), was the biggest gainer this week closing at **370** thebe, whilst **LETSHEGO** (-5 thebe) was the biggest loser of the week closing at **104** thebe.

Market trading activity for the week led to a turnover amounting to **BWP8,127,257** as **5,423,596** securities exchanged hands. **LETSHEGO** (61%) was the biggest contributor to the week's turnover followed by **NAP** (17%).
