

#### MARKET COMMENTARY

The **DCI** ticked up by 0.09% to close the week at 6741.71 points. The **FCI** had a flat week, to close at 1548.83 points. **Letshego** (+2 thebe), was the biggest gainer for the week closing at 107 thebe, while **Chobe** (-10 thebe), was the biggest loser for the week closing at 740 thebe.

Turnover for the week amounted to BWP5,550,646 as 1,682,876 securities exchanged hands. BIHL (57%), was the biggest contributor to the week's turnover.

#### **COMPANY NEWS**

#### **Letshego Group Interim Results June 2021**

Letshego has released its half year results. Key highlights include 12% increase in net interest income to BWP1.02 billion (H1 2020: BWP910.4 million). Other operating income increased by 33% to BWP114.4 million (H1 2020: BWP85.8 million). Expected credit losses increased by 7% to BWP75.7 million (H1 2020: BWP70.9 million). Profit before tax increased by 20% to BWP544.1 million (H1 2020: BWP442.7 million). A lower effective tax rate of 42% (H1 2020: 45%) translated to a 28% increase in profit after tax to BWP313.7 million (H1 2020: BWP244.6 million). Basic earnings per share were 13.4 thebe (H1 2020: 10.7 thebe). The balance sheet grew by 25% to BWP13.34 billion (H1 2020: BWP10.65 billion). Net advances to customers increased by 20% to BWP11.10 billion (H1 2020: BWP9.26 billion). Borrowings increased by 21% to BWP5.86 billion (H1 2020: BWP4.81 billion). Customer deposits increased by 98% to BWP988.9 million (H1 2020: BWP499.0 million). An interim gross dividend of 7.3 thebe per share has been declared.

#### CA Sales Condensed Interim Financial Results for the half year ended 30 June 2021

CA Sales has released interim results. Key highlights include 2% increase in revenue to ZAR3.58 billion (H1 2020: ZAR3.48 billion). Gross profit increased by 1% to ZAR499.1 million (H1 2020: ZAR491.3 million). Operating profit increased by 58% to ZAR146.5 million (H1 2020: ZAR92.2 million). Net profit went shot up by 118% to ZAR96.3 million (H1 2020: ZAR44.0 million). Diluted earnings per share were 19.43 cents (H1 2020: 8.30 cents). The balance sheet grew 5% to ZAR3.18 billion (H1 2020: ZAR3.02 billion).

#### BIHL Unaudited Consolidated Financial Results for the half year ended 30 June 2021

BIHL has released interim results. Key figures include a 28% increase in net insurance premium income to BWP1.56 billion (H1 2020: BWP1.21 billion). Fee revenue went up by 16% to BWP61.6 million (H1 2020: BWP53.0 million). Share of profit of associates and joint ventures net of tax increased by 10% to BWP123.9 million (H1 2020: BWP112.6 million). Net profit decreased by 24% to BWP203.5 million (H1 2020: BWP266.4 million). Earnings per share attributable to ordinary equity holders of the parent were 72 thebe (H1 2020: 72 thebe). The balance sheet contracted by 4% to BWP17.30 billion (H1 2020: BWP17.93 billion).
