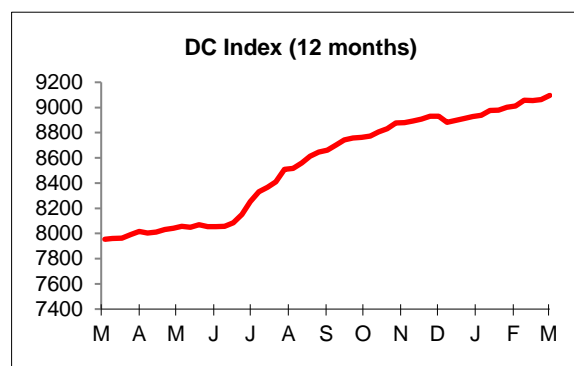

## MARKET COMMENTARY

The **DCI** increased by **0.36%** to close the week at **9096.18** points. The **FCI** remained flat to close the week at **2472.89** points. The **DCTRI** increased by **0.36%** to the close the week at **2827.85** points. **Fnbbs (+7 thebe)**, was the biggest gainer this week closing at **464 thebe**, whilst **Primetime(-5 thebe)** was the biggest loser of the week closing at **165 thebe**.

Market trading activity for the week led to a turnover amounting to **BWP 14,815,456** as **3,015,971** securities exchanged hands. **FNBB (52%)** was the biggest contributor to the weeks turnover followed by **BIHL (16%)**.

## **COMPANY NEWS**

### **CHOPPIES - update to dividend payment**

The Company announced a dividend for the six-month period ending 31 December 2023 through announcements on the BSE and JSE on 29 February 2024 and 15 March 2024 respectively. Eligible shareholders on the Company's JSE and BSE registers on 05 April 2024 were informed about the dividend. Due to a large number of shares held by about 1,600 BSE registered shareholders, dividends of BWP15 or less will be paid in cash to avoid high banking charges. Shareholders could claim cash dividends by contacting the Investor Relations Executive and providing necessary identification or incorporation documents. Unclaimed cash payments would be held in trust for the benefit of the shareholder according to the Constitution of Choppies. Incomplete contact information for approximately 2,200 shareholders in the omnibus Central Securities Depository (CSD) account prevented EFT payments, and the Company would hold the dividends in trust until lawfully claimed. Shareholders whose shares are currently held in the omnibus register were encouraged to open CSD accounts to enable electronic transfers of dividends and were informed that unclaimed dividends after 3 years could become the property of the Company.

### **TLOU - placement of entitlement offer shortfall**
