1. The Procurement Method is, Open Domestic Bidding.
2. The Evaluation method is, Least cost selection for works.
3. Tenderers must, in order to be considered for award of this contract, be registered with Public Procurement Regulatory Authority (PPRA) under **Grade C – Code 06: Specialised Construction Works**, with **sub-code: 01 Sports fields (turf and running track)** and Code 303, sub code 03 Civil Engineering services - Infrastructure (subject to online verification)
